# **NOMINATION CATEGORIES**

#### LIFETIME MEMBER AWARD

This award recognises researchers who have made substantial long-term career contributions to radiation medicine, demonstrating exceptional scientific leadership over their career and advancing TROG's mission.

#### Eligibility

- 1. Completed their primary qualification at least 20 years ago or nearing retirement.
- 2. Been a member (full or affiliate) of TROG for at least 10 years.
- 3. Currently an active full TROG member.

#### **Award Criteria**

- 1. Significant, long-term contributions that distinguish their scientific work.
- 2. Strong leadership in TROG initiatives: chairing committees, mentoring, and policy influence.
- 3. Strong publication record, particularly for high-impact and policy-changing work.
- 4. Notable leadership in advancing TROG's goals internationally and nationally, as well as in quality assurance systems.

#### **Distinct Focus**

Recognising long-term, high-impact leadership and a lasting scientific legacy in radiation medicine and TROG's research.

#### **OUTSTANDING CONTRIBUTION AWARD**

This award celebrates mid-career researchers for their leadership and innovative contributions to advancing radiation medicine and TROG's mission.

#### Eligibility

- 1. Completed primary qualification at least 10 years ago.
- 2. Been a TROG member (full or affiliate) for at least 5 years.
- 3. Currently a full, active TROG member.

# Award criteria

- 1. Notable clinical research and contributions in the radiation medicine field.
- 2. Strong publication record, emphasising work that has influenced clinical practice.
- 3. Demonstrated leadership through involvement in TROG committees and research management.
- 4. Contributions toward improving TROG's radiation therapy quality assurance systems.

#### **Distinct Focus**

Targeting mid-career researchers who demonstrate leadership and innovation, influencing both clinical research and TROG's operational excellence.

# **TRIAL EXCELLENCE AWARD**

Recognises a trial team for exceptional performance in the conduct of clinical trials that have advanced radiation medicine practice.

## Eligibility

- 1. TROG member for at least 5 years.
- 2. Current full, active member.
- 3. Nominee is the Trial Chair for the nominated trial.

## Award criteria

- 1. Outstanding contributions by a team in conducting impactful radiation oncology trials.
- 2. Proven record of high-quality, influential trial outcomes and publications.
- 3. Demonstrated leadership and skill in conducting complex clinical research.

# **Distinct Focus**

Recognising the collaborative excellence of a trial team in conducting groundbreaking trials that yield significant clinical practice advancements.



#### **EMERGING CLINICAL RESEARCHER AWARD**

Acknowledges early-career clinical researchers who have demonstrated promise through innovative research in radiation medicine.

#### Eligibility

- 1. Within the first five years post-PhD or specialist qualification in Radiation Oncology, Radiation Oncology Medical Physics (ROMP), Radiation Therapy (RT), or other relevant disciplines (e.g., Speech Pathology, Medical Oncology), taking into account career interruptions or periods of part-time employment, consistent with relative-to-opportunity considerations
- 2. Current full or affiliate member of TROG.

#### Award criteria

- 1. Original research contributions and innovation in radiation medicine.
- 2. A solid record of early-career publications, showcasing potential for long-term impact.
- 3. Active involvement in clinical trials and mentorship roles.

**Distinct Focus:** Highlighting the innovation and potential of early-career researchers who are making their mark on radiation medicine and TROG's future.

#### PEER RECOGNITION AWARD

This award celebrates professionals in clinical trial support roles who have provided exceptional service to TROG and the broader radiation oncology community.

# Eligibility

- 1. Employed in a clinical trial support role, such as a Trial Coordinator, Radiation Therapist, Medical Physicist, or Research Coordinator.
- 2. Based at an institution affiliated with TROG (excluding TROG Central Operations).
- 3. TROG member for at least 2 years and currently active.

#### Award criteria

- 1. Outstanding contributions to support the conduct of TROG clinical trials at their department/hospital.
- 2. Demonstrated involvement with TROG activities, programs, and/or events.

# **Distinct Focus**

Acknowledges professionals in support roles who have played a pivotal part in advancing TROG's clinical trial activities and organisational success.

## **SECONDARY DATA ANALYSIS AWARD**

This award recognises researchers who have made significant contributions by utilising existing data from TROG clinical trials to generate new insights in the field of radiation medicine.

#### Eligibility

- 1. Current full or affiliate member of TROG.
- 2. Been a TROG member for at least 3 years prior to the award date.
- 3. Demonstrated significant contributions through secondary analysis of TROG's clinical trial data or other relevant sources in radiation medicine.

# **Award criteria**

- 1. Used secondary data analysis to generate original and meaningful insights that advance radiation medicine.
- 2. The analysis has contributed to new hypotheses, treatment protocols, and/or enhanced understanding of clinical outcomes.
- 3. The nominee has produced peer-reviewed publications resulting from secondary data analysis, with emphasis on high-impact publications and incorporation into clinical practice or policy.

## **Distinct Focus**

The Secondary Data Analysis Award emphasises innovative re-use of existing clinical trial data, fostering new discoveries and maximising the impact of completed studies in radiation medicine.
